These Dr.Sum Copilot (Technical Preview) Terms of Use ("Terms") define the conditions that apply to Customers ("Customer") who will use the function to generate SQL and Python scripts from natural language to be used with Dr.Sum and Dr.Sum Cloud ("Function") provided by WingArc1st Inc. ("WingArc"). The Customers shall be deemed to have agreed to the Terms upon download of the Function or application to use the Function, whichever comes first. The Terms apply in addition to the terms and conditions that apply to Dr.Sum and Dr.Sum Cloud (Software License Agreement and Dr.Sum Cloud "Terms of Use"; "Original Terms"). For matters not stated in the Terms, the Original Terms shall apply. Furthermore, in the event of any conflict between the Terms and the Original Terms, the contents of the Terms shall take precedence.

Article 1.Application

- 2. WingArc may add new features to the Function, change its specifications, or suspend or terminate provision of the Function, without prior notice to the Customer. In addition, should WingArc suspend or terminate provision of the Function, it is the responsibility of the Customer using Dr.Sum to uninstall the Function, delete Customer's data, and change the settings of linked Third-party service ("Configuration Changes").
